### Panhandle-Plains Federal Land Bank Association, FLCA Randall County, Texas

The charter of Panhandle-Plains Federal Land Bank Association, FLCA (Association), which is affiliated with the Farm Credit Bank of Texas, is hereby amended so that the name of said Association shall be Panhandle-Plains Land Bank, FLCA.

The title of the Articles of Association of the above Association, which now reads: "Articles of Association for Panhandle-Plains Federal Land Bank Association, FLCA," is amended to read: "Articles of Association for Panhandle-Plains Land Bank, FLCA."

The first Article of the Articles of Association, which now reads:

FIRST: The name of the Association shall be Panhandle-Plains Federal Land Bank Association, FLCA,

is amended to read:

FIRST: The name of the Association shall be Panhandle-Plains Land Bank, FLCA.


The foregoing amendments are effective August 1, 2006.

# Charter

## Panhandle-Plains Federal Land Bank Association, FLCA Gray County, Texas

The Farm Credit Administration, in accordance with the Farm Credit Act of 1971, as amended (Act), hereby charters a Federal Land Credit Association, which is a Federal Land Bank Association possessing authority to make and participate in long-term real estate mortgage loans. This Federal Land Credit Association shall be known as Panhandle-Plains Federal Land Bank Association, FLCA (Association). The location of the principal office of the Association shall be in the City of Pampa, County of Gray, State of Texas. The Association is a Farm Credit institution and a federally chartered instrumentality.


By this Federal charter, the Farm Credit Administration hereby authorizes said Association to exercise all powers conferred on the Association under the Act and the regulations of the Farm Credit Administration within the following territory:

In the State of Texas, the Counties of Armstrong, Briscoe, Carson, Floyd, Gray, Hale, Hansford, Hemphill, Hutchinson, Lipscomb, Motley, Ochiltree, Oldham, Potter, Randall, and Roberts and that portion of Hall County south of the center of the Prairie Dog Town Fork of the Red River and west of the line formed by the western boundaries of Sections 10 and 49 in the J. Poitevent Block 1 and Section 13 in the A. B. & M. Block A, thence from the southwest corner of Section 13 in the A. B. & M. Block A diagonally to the northwest corner of Section 14 in the Melvin & Stewart Block J, thence south along the western boundaries of Sections 14 and 13 in the Melvin & Stewart Block J and the western boundaries of Sections 78, 77, 76, 75, 74, 73, 72, 71, and 70 in the Denison & Pacific R.R. C & O. Block S.



Federal Land Bank Association of Amarillo  
Randall County, Texas

The Charter of the above Association, which is affiliated with the Farm Credit Bank of Texas, is hereby amended so that the name of said Association shall be Panhandle-Plains Federal Land Bank Association instead of the Federal Land Bank Association of Amarillo. The headquarters shall be in the City of Pampa, County of Gray, State of Texas.

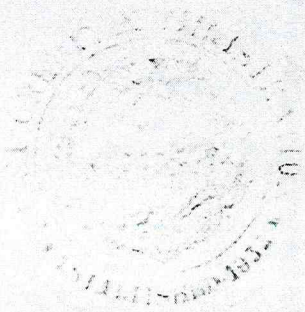
The Charter is further amended so that the designated territory of said Association shall be as follows:

In the State of Texas, all of the Counties of Lipscomb, Ochiltree, Hansford, Hemphill, Roberts, Hutchinson, Gray, Oldham, Potter, Carson, Randall, Armstrong, Briscoe, Hale, Floyd, and Motley, and that portion of Hall County south of the center of the Prairie Dog Town Fork of the Red River and west of the line formed by the western boundaries of Sections 10 and 49 in the J. Poitevent Block 1 and Section 13 in the A. B. & M. Block A diagonally to the northwest corner of Section 14 in the Melvin & Stewart Block J, thence south along the western boundaries of Sections 14 and 13 in the Melvin & Stewart Block J and the western boundaries of Sections 78, 77, 76, 75, 74, 73, 72, 71, 70 in the Denison & Pacific R.R. C & O. Block S.

The foregoing amendments are effective at the beginning of business February 1, 1997.
